In consideration of being allowed to participate in any way in the VOL-TEN CORP., dba SUNSHINE RIVER ADVENTURES program, its related events and activities, I acknowledge, appreciate, and agree that:

- The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis or death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury or death does exist; and,
- I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, even if arising from the negligence of the releasees or others, including but not limited to loss of control of the raft, collision with other participants, rocks, trees, and any portion of the interior of the raft, other rafts, and any other manmade or natural obstacles, whether they are obvious or not; submersion in water, drowning, encounters with wild animals, wildlife and insects, exposure to extreme temperatures and inclement weather, wilderness terrain, and unavailability of immediate medical attention in case of an injury, and hereby assume full responsibility for my participation, and,
- I understand and acknowledge that VOL-TEN CORP. dba SUNSHINE RIVER ADVENTURES provides foot cups in some of the boats to assist participants in stabilizing themselves and although these foot cups assist participants from falling out of a boat, the use of foot cups may present an increased risk of knee, ankle or other injuries due to their restrictive nature, and their use is totally voluntary, and,
- I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of SUNSHINE RIVER ADVENTURES immediately; and,
- I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY AND HOLD HARMLESS THE VOL-TEN CORP., dba SUNSHINE RIVER ADVENTURES, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used for the activity. ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presence or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.
